REMEMBRANCE DAY IN GETTYSBURG

Dear Brothers,

Hello and greetings! For those that don't know me, I am Dave Hann and I serve as Provost Marshal for the Annual Remembrance Day. This year the parade is set for Saturday November 20th, in Gettysburg, PA. For those that have never attended the parade, it is something that you need to experience. For us in the SUVCW it is a chance for us to participate. For those of us that live in New Jersey, Gettysburg is only a few hours away. I know that there are questions about participation in the parade and whether you need to have a uniform or not.

All persons participating in the annual Remembrance Day Parade will be dressed in American Civil War era attire or Grand Army of the Republic uniform. Military uniforms worn will be either Union or Confederate military originals or reproductions or Grand Army of the Republic originals or reproductions. Civilian attire of the mid 1800's is acceptable. Footwear must be appropriate for the Civil War era uniform or dress authorized by this Order. Parade participants may not wear sandals, sneakers and similar modern-day footwear. Only the following will be permitted to march in the annual Remembrance Day Parade in modern business suit or dress attire with the badge of their Order affixed. Brothers of the Sons of Union Veterans of the Civil War, Sisters of the daughters of Union Veterans of the Civil War, Sisters of the Republic, Sisters of the Auxiliary to the Sons of Union Veterans of the Civil War, Members of the Military Order of the Loyal Legion of the United States. Simply stated if you are not a reenactor and you wish to march have a suit with the badge of the order affixed you are good to go. It would be great to see more and more of our brothers

participate. Always remember that your SUVCW Camp flags are welcome in the parade. Another small fact that many of our brothers may not know about and that is the SVR Breakfast. The SVR Breakfast is a great time and gives you the chance to meet Brothers from other Departments. The Breakfast is held at the Gettysburg Wyndham Hotel, 95 Presidential Circle, Gettysburg, Saturday 20 November 2021 8:00 AM There are no tickets sold at the door and you must order them. Several brothers are working independently to clean cemeteries and tombstones of deceased Civil War veterans. On an extremely hot August 7, Brothers Dave Hann, Frank Tomasello, Chuck Gordinier and Larry McDermott {pictured below} met at

the Greenmount cemetery in Hammonton, NJ (with the permission of the cemetery). Several Civil War veterans' stones were thoroughly cleaned with Orvus soap and D2 was then applied to remove biological staining. A noticeable difference resulted with further improvement expected over time.

Additionally, they received sponsorship from The Good Cemeterian to clean all of the tombstones (estimated 150) located in historic Wescott Free Burying Ground in Mays Landing, NJ. The cemetery dates back to the late 18th century and there are three known Civil War veterans buried there. They hope to complete before cold weather sets in this year.

After a year or more of public inactivity due to the pandemic, Stratton Camp and our performance arm, Becks' Philadelphia Brigade Band, have begun to get back to our mission. We literally spent all summer working on audio and video recordings, including a 75-minute virtual concert. This concert featured what we call Becks' Talks, wherein members discuss various aspects of Civil War history. These talks focused on such topics as:

Women in the Civil War

The evolution of the National Airs to the Star-Spangled Banner being named as our official Nation Anthem

The importance of honoring those who fought, along with the story of one brother's ancestor

The history of the Philadelphia Brigade and the band's role in the war

The role musicians played in everyday camp life and in battle, including entertainment to raise morale, and bugle and drum calls

Recruitment methods throughout the war, using bands as a way to draw crowds and foster a sense of patriotism

The period instruments and how they were used during the war

We plan to expand these "Talks" into the future. We use these talks at our band performances, all with the purpose of raising awareness and honoring our heroes.

As fall approaches, we begin to perform much more. Some of those coming up include:

9/2: A concert in Avalon, NJ in honor of VJ Day

9/10: A 9-11 concert in Doylestown, Pa. to promote education about that sad day.

9/11: A similar concert in Washington Twp. To honor our loss on 9-11 and to promote historical awareness

9/26: A long-delayed Memorial Day parade in Malvern, Pa.

10/13: An historical concert for an assisted living facility in Washington Twp., NJ

10/24: A Civil War Days concert in Glassboro, NJ, honoring the men and women who fought, especially those from this area of the state

11/13: A Veterans' Day ceremony in Pittsgrove, NJ, honoring all who fought from the area.

11/20: Remembrance Day in Gettysburg, what we call "The best day of the year".

This is also our longest, beginning in early morning with several monument ceremonies, including Albert Woolson. The parade follows at 1 PM and we end the day by playing for the SVR National Ball until midnight. Great day!

12/31: We end the year with a ceremony honoring General George Meade on the occasion of his birthday. This is held every year in historic Laurel Hill Cemetery in Philadelphia.

During each and every one of these, our goal is to educate audiences about their history as it pertains to the Civil War and the effect that awful conflict has had on America to this day.




DEPARTMENT NEWS

PDC Ronald L. Brower



Our esteemed Brother Ronald L. Brower passed away on August 27, 2021. He was born on July28, 1934 in Philadelphia, PA. His great-grandfather, Joel Brower, served in Companies F and M of the 2nd New Jersey Cavalry from September 19, 1864 to June 29, 1865. He joined Abraham Lincoln Camp 100, The State Camp of New Jersey, on April 10, 1993. He served as Commander of Lincoln Camp 100 (2008-2010), and was Commander of the New Jersey Department, SUVCW, from (2012-2014). He also served as Captain of Company A, 1st New Jersey Infantry, Sons of Veterans Reserve (2013-2018). At the time of his passing, he was long-time Chaplain of the New Jersey Department and of Lincoln Camp 100, as well as Senior Vice Commander of Camp 100. His sons Charles L. Brower, Curt Brower and Ronald G. Brower, and his grandson Matthew Brower, are also members of the SUVCW. He was a proud supporter of his country, participating in the National Guard, and also a dedicated parishioner of Pinelands Reformed Church in Toms River, NJ where he was also a Visitation Pastor. Our sincere consolations to his wife Jeanne and their family.

1ST LT. JOHN JAMES TOFFEY N.J. MOH

B: June 1, 1844 Pawling, New York

D: March 13, 1911Pawling, New York

Enrolled in Co C 21st NJ Infantry on August 28, 1862, Mustered in September 15, 1862 in Hudson, NJ and served as a private for the nine month's duration of the regiment's service

He mustered out on June 19, 1863

On August 23, 1863, he was commissioned as a First Lieutenant in Co F, 33rd NJ Infantry and was mustered in August 29, 1863

The Medal of Honor was awarded to Lieutenant John James Toffey on September 10, 1897 for his act of bravery at the Battle of Missionary Ridge, Chattanooga, TN on November 22, 1863

CITATION: Although excused from duty on account of sickness, went to the front in command of a storming party and with conspicuous gallantry participated in the assault of Missionary Ridge: was here wounded and permanently disabled.

He was discharged from the 33rd NJ on June 2, 1864 because of his hip wound and served as a Lieutenant in the Veteran Reserve Corps until June 1866

Lt. Toffey was present at Ford's Theater when President Lincoln was assassinated.

He participated in the search for the conspirators, testified at their trial and witnessed their executions. After the war, Lt. Toffey led a life of extensive public service in New Jersey

2 terms as Hudson County Sheriff, State Treasurer from 1875 to 1891, served in the State Legislature and was an Alderman in Jersey City. He is buried in the Pawling Cemetery, Pawling, NY

Br. James found out about the "Sons" while attending New Jersey Day at Gettysburg, in 2013. This event was hosted by Brother Dr. David Martin. Br. James looked into the SUVCW and applied for membership. Br. James is currently the Junior Vice Commander of General Phillip Kearny Camp 20 Department of New Jersey.

James has the honor of presenting Scouts with the SUVCW certificate upon attaining the rank of Eagle Scout. A long-held tradition of the SUVCW.Br. James has been part of scout trips to Gettysburg. The scouts are eager to learn. Currently Br. James is part of Project Remembrance. The Brothers of Kearny Camp are attempting to locate and mark where GAR Posts met in New Jersey. Sadly, there are no pictures of Patrick. They were destroyed in a fire at a family member's house many years ago. Artist Illustrations show us what Patrick and the United States Marines and Navy looked like during the civil war.

ANCESTOR OF

James J. Halloran jr.

Marine Corp Pvt. Patrick Halloran

Br. James Great Grandfather Patrick Halloran enlisted on January 7, 1862 in Company D, 1st NY Marine Artillery. He was three months shy of his fifteenth birthday. They served on Union gunboats. On February 7, 1863, the unit was in action as part of Burnside's expedition to capture Roanoke Island, Elizabeth City, Newburn and Beaufort, North Carolina. After the capture of these places, the Marine Artillery was used to patrol Roanoke and Albemarle Sounds. They also used horses to make raids on Rebel guerrillas. They picked up the nickname as "Horse Marines." The unit was disbanded in early 1863. Patrick was at Beaufort, at that time. He enlisted in the US Navy as a Landsman. There is a report in the NOR of a Patrick Halloran, Landsman, missing in action after a boat attack on Fort Sumter. He was discharged on February 7, 1864. Patrick took a short rest and then enlisted at the Brooklyn Navy Yard as a Coal Heaver aboard The USS Berberry, an armed steam tug. The Berberry was on blockade station off of Fort Fisher, NC, on October 5, 1864, when her sister ship USS Aster chased a blockade runner. Both ships ran aground. Aster requested a tow. Berberry passed over a tow line but it parted. The Berberry took the crew off the Aster and she was set on fire. The Fort started firing As the Berberry churned for deep water, it was found out that the tow rope was now wrapped around the propeller! Every bit of canvas and sheets were spread in the rigging as sails. It worked! Patrick was discharged on June 12, 1865. He joined Edward G. Brown Post #44, GAR, in Hoboken.
